Officer reports:

- E) State convention June 14 and 15, in Wisconsin Dells: 9 delegates will be attending, when in convention hall sit with CD8
- F) Office layout: Stu and Dave have been making changes, Tracy and Stu will be making changes to our organizational chart, selecting committee heads,
- G) Movement labs: no updates yet
