### Henry Fries is out, but not down

Henry Fries lost decisively when he ran as an independent for State Assembly District 40 against GOP incumbent Rep. Kevin Petersen.

"The barrier to our shared goal, victory over a 16-year incumbent, was too great for us to overcome," Fries said in a statement.

His strongest showing was in Waupaca County, where he won 5,449 of his 6,296 total votes in District 40. Petersen also got most of his votes in Waupaca County, 16,152 out of his total 19,361.

Fries, 18, said he will set aside electoral politics for now, while he focuses next on gaining broader perspectives in college.

Despite the loss, "our fight is not over," he said. "The voice of this young generation will not be forgotten."

### Two progressives run in the Feb. 21 primary for Wisconsin Supreme Court

At least two progressive candidates will vie for a seat on the Wisconsin Supreme Court in the primary election on Feb. 21, 2023. The outcome of the election on April 4, 2023, will decide whether the majority of the seven-member court is liberal or conservative.

The two progressives in the race are Dane County Circuit Judge Everett Mitchell and Milwaukee County Circuit Judge Janet Protasiewicz.

Two conservative candidates have announced. Republican-backed Dan Kelly was appointed in 2016 and defeated in 2020 by progressive Jill Karofsky. Waukesha County Judge Jennifer Dorow, judge in the Waukesha parade-deaths trial, made her candidacy public on Nov. 29. She will vie for GOP support.

In the race, officially nonpartisan, only two candidates will

advance from the primary to the general election to fill the seat of Justice Pat Roggensack, who is in the current four-justice conservative majority. She is retiring after two 10-year terms.

In the next few years, the court is expected to rule on a wide range of issues, from abortion access to redistricting of legislative maps.

Dec. 1 is the starting date for collecting signatures on nomination papers. The deadline for judicial candidates to file is Jan. 3.

### Concern about book bans might drive school board elections

The hot topics in school board elections have shifted from such considerations as how much money to spend on girls' volleyball versus boys' football. Now topics include whether the school library should be cleansed of any books that make people feel uncomfortable.

Progressive candidates for the 2023 elections in Waupaca County who are concerned about book banning and other conservative goals are invited to receive campaign help from the Waupaca County Democratic Party. These include a meeting place, buttons, and phone banks.

"The school board is responsible for establishing goals, setting policy and overseeing resources for the school district," the Wisconsin Association of School Boards says in its New School Board Member Handbook at *wasb.org*.

Because of staggered terms, two to three board positions are up for election most years School Boards continued on page 4

in each school district. To find the open spots, search online for "(name of city) School Board." The election is officially nonpartisan but often features a divide between conservative and progressive ideas.

Candidates can begin collecting petition signatures on Dec. 1. The deadline for school board candidates to file petitions is Jan. 3.

#### **County book reviews**

The suppression of information has a long, distressing history in the world, including book burning used by the German Nazis as a measure of thought control during the 1930's and 1940's.

In Waupaca County, a written complaint to the Manawa School District resulted in a panel review of the coming-of-age novel *Looking for Alaska* by John Green, the *Waupaca County Post* reported on Dec. 1, 2021. Manawa district officials did not respond by press time to two requests for the results of the review.

At the Waupaca Public Library, the award-winning book is shelved in an area called the Teen Room. Library Director Eric Bailey said the public library has received a written "Request for Reconsideration" about two books this year, neither to that book.

The requests "never reached the level of a panel review," he said. Both were resolved through interaction with the patrons.

Books unite us, censorship divides us, Manawa District Library Media Specialist Jen Krueger told the *County Post* in the 2021 article. "Students need to see themselves in the books they read. They also need to see others that are unlike them," she told the Post.

#### Did a Texas pol start this push?

The recent push for book banning in schools might have started with a letter by GOP State Rep. Matt Krause of Texas District 93. On October 25, 2021, as chair of the Committee on General Investigating, he wrote to public school officials asking for an investigation into a 16page list of books — he wanted to know where the books were located in school libraries and the amount of money they cost.

He wanted districts to identify materials "that address or contain the following topics: human sexuality, sexually transmitted diseases, or human immunodeficiency virus (HIV) or acquired immune deficiency syndrome (AIDS), sexually explicit images, graphic presentations of sexual behavior that is in violation of the law, or contain material that might make students feel discomfort, guilt, anguish, or any other form of psychological distress because of their race or sex or convey that a student, by virtue of their race or sex, is inherently racist, sexist, or oppressive, whether consciously or unconsciously."

Within a year, Texas led the nation in book banning in schools, with more than 800 titles removed, the *Dallas Morning News* reported on Sept. 19, 2022.

At the time Krause raised his questions, he was running for attorney general of Texas but he dropped out before the primary.

# Additional nonpartisan offices on spring 2023 ballot

In addition to a state Supreme Court justice and school board members, the nonpartisan spring election in Wisconsin includes "every elective town, village and city office," says the *Wisconsin Blue Book* (2021-2022 edition). Also on the ballot will be additional judges, some county offices, and the state superintendent of public instruction.

Progressive candidates are invited to receive non-financial campaign help from the Waupaca County Democratic Party.

Because of staggered terms, not every position will be open for election every year.

#### JUST THE FACTS

Respect for Marriage Act passes Senate, goes to Biden

A bill to ensure that same-sex and interracial marriages are enshrined in federal law was passed on Nov. 29 by the U.S. Senate on a bipartisan 61-36 vote. The Respect for Marriage Act, H.R. 8404, goes to President Joe Biden for signing.

The bill repeals the Defense of Marriage Act of 1996, which defined marriage as between one man and one woman.

In the Wisconsin delegation, Democratic Sen. Tammy Baldwin voted yes. She was the first openly gay senator in 2012; she married her wife in 2018. GOP Sen. Ron Johnson voted no. *senate.gov; congress.gov; pbs.org; jsonline.com;* 

Candidates must collect signatures on a nomination petition and file the nomination papers not later than the first Tuesday in the January preceding the spring election. In 2023, that is Jan. 3.

If only one candidate files for an office, that candidate will not be on the nonpartisan primary ballot on Feb. 21, 2023, but will advance directly to the April 4 general election. In general, if more than two candidates file, they will need to run in the primary election.

### Dec. 3 elections postponed

Another key event at the meeting Dec. 3 will be the call for a panel of volunteers to decide on priorities in calendar year 2023. Once volunteers are gathered, a one-time meeting is intended.

Most outreach stopped in 2020 and 2021 because of Covid, departures, and deaths. In 2022, the group participated in the Manawa Rodeo Parade and the County Fair.

Activities that could be resumed include representation at community festivals in Iola, New London, Scandinavia, Waupaca, and Weyauwega.

# Some midterm vote totals from Waupaca County

In the midterm races for governor/lieutenant governor and U.S. senator, the votes in Waupaca County were about 2 to 1 for the Republican candidates over the Democrats.

Gov. Tony Evers was reelected with Sara Rodriguez as lieutenant governor by about 90,000 votes over GOP hopeful Tim Michels with Roger Roth as lieutenant governor. In Waupaca County, the Evers ticket got 7,990 votes to 14,939 for the Michels ticket. Mandela Barnes, the former lieutenant governor who ran for U.S. Senate, got slightly fewer votes in Waupaca County than Evers -7,653 for Barnes to 15,525 for GOP incumbent Sen. Ron Johnson.

In the race for the 8th Congressional District seat, Julie Hancock, a late entrant as a Democratic write-in, got 213 votes in Waupaca County to 17,162 for GOP incumbent Rep. Mike Gallagher. Another Democratic write-in, Robbie Hoffman, got 11 votes in Waupaca County. Libertarian Jacob J. VandenPlas and Independent Paul David Boucher both received tens of thousands of votes among the 310,196 votes cast in the 8th.
