Dave K made a motion to approve the agenda, Phil W seconded, motion carried.

### **Officer reports:**

Dave made a motion to accept the secretary's report, Phil seconded after the following correction: Mark Scheffler is running for 8th CD, not 5th. The motion carried.

Tracy gave the treasurer's report. She and Stu both reported some outstanding checks. Tracy also noted that taxes for next year are \$672. Phil made a motion to accept the treasurer's report, Dave seconded, motion carried.

- D. Sign post installation and Chris Taylor signs: Tom O, Dave K, and Mark P have 40 posts in the ground, ready for signs. Bob C made the phone calls to land owners. Taylor signs will arrive 45 days before election.
- E. Recycle ink cartridges, donate to food pantry, recycle signs and rechargeable batteries: Everyone please continue to contribute to these ongoing projects. We have earned over \$300 from Staples for office supplies for next year.
- F. Nomination papers: December 1st was the start date. Papers are due in the Waupaca office by December 19th. They will be mailed on the 20th.
- G. Our state office representative for local counties has changed position and we will therefore have a new one in January.
