

Waupaca County Democratic Party Membership Meeting

- D) Update spring elections : 7,500 postcards were sent for elections April 1st Crawford, Underly, and vote "no" on amendment

GOTV will begin this week in Waupaca, New London, and Clintonville using primarily door hanger bags.
