### **Evers, Kaul sue GOP leaders**

Gov. Tony Evers (D) and Attorney General Josh Kaul (D) filed a suit 28 June 2022 in Dane County Circuit Court against Republican legislative leaders over reproductive health-care rights in the state. After the U.S. Supreme court overturned the 1973 Roe v. Wade ruling, on June 24, 2022, the suit argues that that the 1849 state law conflicts with reproductive health-care measures that have been passed since 1973. Evers had requested a special legislative session to amend the 1849 law, but Republicans gaveled in and immediately out of the special session on June 22, 2022.

# High court lifts a gun restriction; new law adds gun restrictions

On June 23, 2022, the U.S. Supreme court struck down a New York state law that required people to demonstrate a need to carry a gun in order to get a license to carry one in public. The ruling is expected ultimately to allow more legal guns to be present on roads and streets.

But on June 25, 2022, President Joe Biden signed into law the Bipartisan Safer Communities Act (S.2938), which enhances background checks for gun buyers 21 years of age, provides funds for mental-health services, and closes the so-called "boyfriend loophole" to prevent convicted domestic abusers from buying a firearm for five years. Some other provisions: Incentives for crisis-intervention programs, clarification of the definition of a federally licensed firearms dealer, and penalties for straw purchases (when a buyer obtains a gun on behalf of someone else) and gun trafficking.

After decades of mass shootings in America, bipartisan support for gun restrictions finally came together after the May 2022 killings at a school in Uvalde, Texas, and at a supermarket in Buffalo, N.Y.

Biden.

### Sen. Johnson's electoral scheme

On June 21, Sen. Ron Johnson (D-Wis.) denied testimony in the Jan. 6 hearings that said he had tried to deliver lists of Wisconsin and Michigan alternate electors to then-Vice President Mike Pence. On June 23 he admitted that he had coordinated the effort, and said that the lists had come from the office of Rep. Mike Kelly (R-Pa.). Then, Kelly's office said he hadn't spoken to Johnson in years.

# The Democratic primary ballot

Following the collection of voter signatures, the slate is set for the Aug. 9 partisan primary. The Waupaca County Democratic Party will make no endorsement for any office before the primary. Here are the Democratic candidates on Waupaca County ballots and the length of terms for the offices:

**U.S. Senate, 6 years:** Eight Democrats gathered enough signatures to oppose incumbent Ron Johnson (R). In alphabetical order, they are Mandela Barnes, Milwaukee; Sarah Godlewski, Madison; Alex Lasry, Milwaukee; Kou C. Lee, Hobart; Tom Nelson, Appleton; Steve Olikara,

Milwaukee; Peter Peckarsky, Milwaukee; and Darrell Williams, Milwaukee.

**Congressional District 8, 2 years:** No Democrat is running, but incumbent Mike Gallagher, R-Allouez, has a Republican opponent, Shaun Clarmont, Oneida, and a Libertarian opponent, Jacob J. VandenPlas, Sturgeon Bay.

#### Five Wisconsin Constitutional officers, 4 years:

**Governor:** Incumbent Tony Evers (D) is running unopposed.

Lieutenant Governor: Peng Her, Madison; and Sara Rodriguez, Brookfield.

**Secretary of State:** Incumbent Doug La Follette, Madison; and Alexia Sabor, Madison. **State Treasurer:** Gillian M. Battino, Wausau; Aaron Richardson, Fitchburg; and Angelito Tenorio, West Allis. Incumbent Sarah Godlewski (D) is vacating the office to run for U.S. Senate.

**Attorney General:** Incumbent Josh Kaul, Madison.

**Wisconsin Senate** 

**State Senator District 2** (municipalities of Bear Creek, Clintonville, Embarrass, Lebanon, Matteson, effective until Dec. 31, 2022): No contest in 2022.

**State Senator District 14** (remainder of Waupaca County, effective until Dec. 31, 2022): No contest in 2022.

#### Wisconsin Assembly, 2 years:

**State Assembly District 6** (municipalities of Bear Creek, Clintonville, Embarrass, Lebanon, Matteson, effective until Dec. 31, 2022): William J. Switalla, Wittenberg.

**State Assembly District 40** (remainder of Waupaca County, effective until Dec. 31, 2022): No Democrats or other opponents to incumbent Kevin Petersen, R-Waupaca. *elections. wi. gov* 

#### **County Officers, 4 years:**

**County Sheriff:** No Democrats filed papers to run. **County Clerk:** No Democrats filed papers to run.

## **Technical details for voting**

An absentee ballot can be requested at myvote.wi.gov, available in English and Spanish, or at your municipal clerk's office. Early voting can be done by mail or in person at your municipal clerk's office or at that office in person on Election Day.

Wisconsin early voting for the Aug. 9 primary begins July 26 (14 days before Election Day), and ends Aug. 7.

The United States joined the fighting in 1950 to defend the Republic of Korea (South Korea), established in 1948, when Communist troops invaded from the Democratic People's Republic of Korea (North Korea). The conflict ended by armistice, not a peace treaty. No nation signed it, only military representatives. As of 2021, about 20,000 U.S.
